### PRESIDENT'S MESSAGE

Dear GCTC membership and friends,

It is so nice not to have to rehash the effects of COVID on our organization for a change! Life goes on, and our work continues on the trails.

Two factors are causing record-breaking numbers of people to flood the National Forests. The initial wave was COVID-19 forcing people to find outdoor activities to enjoy, away from the confines of their homes. The second wave is the now record-breaking heat that has settled in over California in the past month. Our home in Grass Valley has regularly hit 100 degrees this month, with the highest being 105—at 2400-ft. above sea level!

These new crowds on the trails and in the forest are often not aware of safe forest and trail etiquette, so please be extra watchful and extra patient when you encounter them. If on horseback, perhaps take a moment to educate folks on how horses see the world. The forest belongs to everyone, and we want everyone to be safe and enjoy the beauty.

On another note, some members have asked: where and how GCTC money is spent. In the last couple of years, GCTC has spent or has earmarked the following funds to enhance and improve trails and the club:

- \$3,571 for the Pines to Mine trail
- \$5,000 authorized for a new equipment trailer for events and workdays
- \$1,000 for a new map signboard at the Gold Country Equestrian trailhead at Lone Grave.

In 2021, GCTC spent \$4,800 grading the road into the Gold Country Equestrian trail head at Lone Grave off Conservation Road. In 2020, the club spent \$2,000 increasing the number of pipe horse corrals at Skillman Horse Camp. GCTC also currently spends \$285 a month for the manure dumpster at Skillman.

Other club expenses are hall rentals, miscellaneous supplies, insurances, and a recently purchased projection screen for enhanced presentations at meetings, so we don't have to project onto a wall or sheet.

All GCTC expenditures are done by consensus after discussion by the Board and Officers and are voted on for approval. The discussions and votes are recorded in the minutes to which club members have open access on the Gold Country Trails Council website.

In closing, I would like to once again thank those members who tirelessly step up and contribute to the success of GCTC and help us live up to our mission statement (in the header above). Thank you to each and every one of you who give of your time, energy and monetary contributions.

If you haven't yet had an opportunity to join this wonderful group of people at one of our events, you have several upcoming opportunities to do just that! Come join us in July and August for a day ride, one of the work/camp/ride events, and the club ice cream social. We'd love to have see you!

## LONEY MEADOW WORK / CAMP / RIDE

JULY 16-18, 2021



**Join us for a weekend or a day of GCTC camaraderie and gorgeous scenery!** Head for the hills and experience the beauty of the Tahoe National Forest while helping to maintain the adjoining trails. This is a dry camp but there is a stream nearby, and everyone camps in a lovely area surrounded by trees. There are no human amenities. There are also no horse accommodations, so you must provide a way to secure your horse: portable corral, Hi Tie, etc.

We will be riding into the area we will be working on. After we are done working (9 am to ~12 pm), we will ride out and explore this beautiful area. If you haven't had the opportunity to ride here, you will be amazed by the miles and miles of mountain trails. And what better way to learn an area than to go with a group of riders who know the trails?

Riders can continue on to Bowman Mountain and the little glacial lake at the top. Then circle down to Lower Rock Lake, ride alongside Texas Creek past Bull Pen and on into Loney Meadow. There is a backcountry that is non-motorized. Ride to Grouse Ridge, or Glacier Lake at the foot of the Black Buttes. Return along Sand Ridge overlooking Five Lakes Basin, Faucherie and French Lake. Or then there is the ride on the Crooked Lakes Trail past Carr and Feeley Lakes. Pass Island Lake and a passel of lakes that are so numerous they have no names. Lunch at Penner Lake and circle back to camp. I'll stop there! As you can see, there are many riding options in this area.

Loney Meadow is not a designated campground and there is no reservation system. It has also become very well-known recently. As it is a first-come, first-serve area, anyone in our group who is interested in going up earlier in the week and possibly staking a claim on our camp area, either in the meadow or near the creek, would be greatly appreciated.

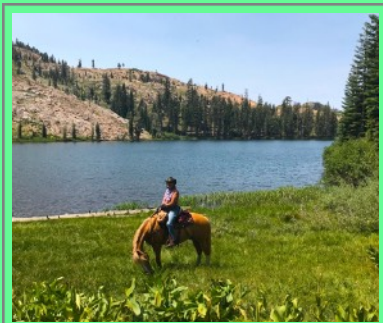
**Come and horse camp for the weekend, OR come for the workday, Saturday, July 17 and bring your horse.** Loney Meadow is close enough to Grass Valley to be a day ride area. We will be riding into the area we will be working on. All of the work will be simply trimming: Piece-a-cake! Please do plan to join us: "Many hands make light work." Bring any small saws or clippers that you can pack on your horse. GCTC will provide loppers.

Four-wheel drive is needed for one small section getting to the camp area. But if you want to come up for the workday, there is a place to park for the day that does not require 4-wheel drive. Please check your email for more information & directions

When folks returned from the morning rides on Saturday, Jeff Foltz had set up a Root Beer Float Bar with an ice chest full of vanilla ice cream, whipped cream, cherries, ice cream cones, cookies and all the cups, spoons, re-usable straws, EVERYTHING to make the Root Beer Float Bar a welcome treat. 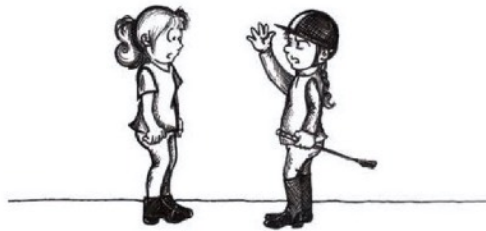

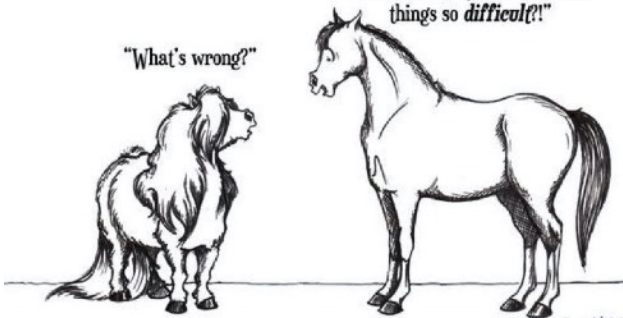

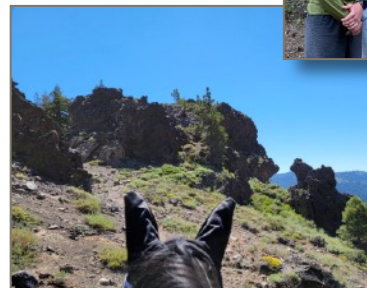
## LITTLE LASIER MEADOW WORK / CAMP / RIDE RECAP

Our Trail Patrol season is in full swing. We have been out there on the trails reporting downed trees, helping lost souls and reporting the illegal use of E- Bikes and motorcycles on the trails etc.

**NOTE:** Current Trail Patrol volunteers, don't forget to report your hours. Our hours count with the Forest Service!

#### **As Trail Patrol volunteers this is what we do.....**

Trail Patrol volunteers are ambassadors on the trails in the Tahoe National Forest. Trail Patrol riders report the hours they spend monitoring the trails and often give a short report on any trail conditions that may need attention, such as downed trees or interactions with other trail users. Trail Patrol Volunteers are welcome to provide as much information as they like, or simply log their hours patrolling. As ambassadors, we interact with other trail users (hikers, bicyclists, families, etc.) and can assist by providing directions or general information about an area, if needed, or just provide a friendly, "Hello."



With the reported hours spent on the trails, GCTC gains credibility as a volunteer partner with the Tahoe National Forest. That in turn aids GCTC in having a voice in planning for trails, campground maintenance, and changes or improvements the club would like to see happen.

I rode at Lone Grave with another GCTC member. We saw a couple of other GCTC members at the trailhead but no other trailers. I chatted with a temp Forest Service gal who was posting a sign and she told me her job this summer is to identify the "extra" trails that have been made and she was told to close them off... bummer! I told her how we love the Edge trail and the berm/ditch trail and it sounds like she may leave those alone.

We headed off to the Edge trail via the Ditch trail and just as we were going to cross the Conservation Rd to get on the Meyer, we waited for two motorcycles that were roaring towards us. We thought they were on the road but as they got around the bend and closer, we realized they were roaring down the Meyer trail and we couldn't do anything to stop them.

We proceeded and after coming up the switchbacks on the Dascombe, we turned right, and then picked up the new little trail off to the left.
