

WELCOME HOME FAY!!

May 18, 2005 my beautiful, buckskin Morgan, Homestead Butterscotch Swirl gave birth to her first foal. She was fussing in her stall and when I went out to check on her at 8 pm, she would not let me leave the stall. She actually blocked the door with her pregnant body. Within 40 minutes she was giving birth. As the foal emerged I was so disappointed to see a bay filly and not the buckskin I was counting on. She was immediately dubbed "Bucking Fay". Use your imagination to figure out how I got that barn name. In time her registered name was to be Terob Bittersweet Kiss. Dark like bittersweet chocolate and sweet like a chocolate kiss, she lived up to her name, and was the sweetest foal I've ever had. At 3 years of age I started her under saddle work and she was a dream to work with. Within a few months I had received an offer to buy her and off to Ohio she went. Nice family with children for this little 13.3 hand filly.



Somewhere along the line things went downhill for this family and despite my repeated attempts to buy Fay back, I was reassured that all was well. This past April I got an email from the gal who had sold Fay's mother to me. The SPCA had seized all 29 horses on the Ohio farm. The charges were neglect. When the SPCA sent a photo of a small horse I told her that couldn't possibly be Fay. I was assured it was. Thin, hairy and covered with lice!! I cried over the phone when I called to tell them I wanted to get my horse HOME!!

Two months of paperwork, locating shippers and a foster home building Fay back up to a healthy state and she was ready to come home. By wonderful coincidence another Morgan owner in Grass Valley had a filly in OH [even the same town] who was coming home. We coordinated and Fay had a ride. Boy do I love my cell phone. Most of the communication with the shipper and the farm where he was to pick her up was done at a rest stop on I-5 north of Kettleman City.

Fay is home now and has put on a lot of weight. Worming, vaccines and a dental float and she really looks good. The SPCA vet had noted something about her eye, so I had Dr. McCarthy check it out. She couldn't see deeply enough into the eye and referred us to Dr. Faber. Lucky for us the visit was before this hot spell and I met him at Loomis Basin Vet Hospital. He gave her a thorough eye exam in both eyes and declared her in good eye health. There were signs of a previous injury and some residual inflam- mation, which I had been treating as per Dr. McCarthy. Whew! What a relief. Now my girl is home and seems to be healthy in all ways. Just as sweet as ever she is very territorial about her feed with the other horses. This I can live with.

Little Lasier Meadow

On a beautiful day, June 9, 2013 a reconnaissance trip was made by Mary Lundin, Gail Plakos and Mary Johnson to determine the repair needs of Little Lasier Meadow Horse Camp. The trio met with Wayne McCarter and Jace Reed of California Land Management to discuss the camp and the type of work to be done. Wayne and Jace are very helpful and supportive of GCTC efforts to continue horse camping in this wonderful area. It is a pleasure to work with them and the rest of the staff. After the short meeting and a walk through in the camp, the recon crew hiked up the connector trail to access its needs. Several fallen trees were discovered on that trail and the PCT (Pacific Crest Trail). There was work to be done for the planned June 28-30 outing!



The delightful and welcome rain set up a real treat for the arrival for some of the Little Lasier Meadow camp out participants on Wednesday. The air was clean and fresh and the gravel road into camp was dust free! The soft mist across the meadow early Thursday morning was a scene worth waking up for and leisurely rides on dust free trails lined with wild flowers in various shades of lavender, blue, pinks, and oranges were the reward for the weekend. Friday brought the steady arrival of the majority of GCTC members who quickly settled into their assigned campsites. Jeff and Willie arrived early so they could get a start on removal of the several downed trees on the connector trail, and the "monster" on the PCT, prior to the Saturday work party. Because of the anticipated warmth, it was decided to start the Saturday work gathering at 7:30 AM. Most everyone retired early, although the unknown site 11 camper had not arrived yet. Around 10:00 PM, the wait ended as a very large rig crept carefully and quietly through camp. A quick hello to the mystery camper revealed Mike and Laurie Sweeney, trail advocates for the Royal Gorge property. Mike joined the GCTC work crew Saturday AM despite his late arrival!

Workers broke into 4 groups: trail trimmers, trail bed construction, camp ground workers, and trail scouts. White thorn brush and Manzanita were cut back off the trail, water breaks were created and the trail bed was enhanced on the connector trail. The PCT (Pacific Crest Trail) north of the connector trail was checked and cleared for equine passage. In camp, low hanging branches were trimmed from the campsites, fire pits were cleaned, corral gates were rehung, and wire was added to the "4-plex" corral. And after all that, the hearty workers dug out the gravel from the plugged culvert and moved the gravel to fill in the ruts (big ruts!) in the campground road. All that in four and 1/2 hour !!!



Although the temperature was warm, the afternoons brought a refreshing breeze...just right for a relaxing ride. GCTC members took advantage of spectacular views from the PCT, lush green meadows, majestic trees and carpets of wild flowers. To top the evening off participants gathered for a delicious potluck then retired for a much-deserved night of rest. Sunday and Monday provided more enjoyed riding, and in most cases easy trips home.

Gold Country Trails Council Minutes of the Board of Directors Meeting June 11, 2013 Memorial Park Annex Building 415 Central Avenue Grass Valley, Ca 95945

The executive board meeting was called to order by President Helen Harvey at 7:02.

Members present included: President: Helen Harvey Secretary: Karen Schwartz Treasurer: Kathy Southgate Board Members: Jeff Foltz, Don Soto, Vicki Testa Forest Service Liaison: Willie Brusin Members: Mary Johnson (Membership Chair), Sue Brusin

Absent: Vice President Melissa Ribley Teri Personeni (Past President)

Helen requested approval of the May minutes. Secretary Karen Schwartz reported that a revised version of the May minutes has been issued to all board members, and the minutes were approved.

Treasurer Kathy Southgate reported that the bank balance as of 6/11/13 was \$14, 820.00. She stated that no billing has been received for the food provided at the Skillman campground workday. She also reported that no billing has been received for the Grange rental. Helen volunteered to contact Sidney Hunt to request a billing.

Board member Jeff Foltz asked about expenses associated with the upcoming barbecue at the board meeting in August. Board members will bring salads or desserts and Jeff will supply the meat entree.

Old Business:

Forest Service Liaison Willie Brusin distributed his report dated 6/2013, including the following items:

Pioneer Trail: The TNF botanist has completed the on-site survey of the wild flowers on the Pioneer Trail relocation area but has not submitted her report. Once the report is submitted, a 30-day period is allowed for public comment before the trail relocation can proceed.

Skillman Campground: Willie reported that Joe Chavez new title is TNF Trails and Recreation Specialist and that Carlos Gonzales is now our contact person for Skillman. The changes proposed for the campground have now been reduced to fire rings and a new vault toilet, probably due to ongoing budget problems. At the May 22nd work day several GCTC board members surveyed the campground to prepare recommendations for TNF representatives on proposed changes, including parking barriers, and considered developing a GCTC proposal. Willie proposed that GCTC develop and propose a master plan for Skillman to be presented during an orientation with Carlos in August or September. In response, board members agreed that a proposal be developed, including a site map, to be presented to Carlos Gonzales in August or September. A site map is needed, and Karen agreed to contact member Jaime Canon, who is experienced in architectural drafting, as to what might be involved. The board voted unanimously to support this proposal with a letter detailing our recommendations and to ask Vice President Melissa Ribley to spearhead this effort.

Upper Pioneer Trail: Willie and Sue recently rode the trail and determined that the trail needs brushing across from the Overlook Vista area. Overgrowth is increasing near the Omega rest stop, and an extra workday may need to be scheduled to remove it.

Other: Board member Don Soto suggested that cyclists carry some sort of sound device to alert horses. Member Sue Brusin recommended that Don contact BONC regarding this idea.

Helen reported that a publicity chair is still needed. Membership Chair Mary Johnson agreed to review members' applications for those who might be interested.

Helen reported that she intends to produce a pdf. format of the membership directory information to be sent to members via email. Kathy reported that she has not received a billing for printing the 2013 membership directory.

Helen asked if the board was satisfied with the GCTC Trail Etiquette Guide included in the GCTC Policies and Procedures manual. The Guide was unanimously approved for distribution to members. It was noted that no dogs or ponying of horses would be permitted at the Poker Ride.

New Business:

Helen reported that food contributions are needed for the Poker Ride and will be coordinated by member Sue Hammontre.

Karen reported that she and member Merrill Kagan-Weston attended an equestrian tour of Royal Gorge, 3000 acres recently acquired by the Truckee-Donner Land Trust. The trails there are spectacular and Karen proposed that the board schedule a day ride there, which she will arrange if there is sufficient interest. The Trust is seeking input from potential recreational users via an outreach survey at royalgorgeoutreach.org, and equestrians should be encouraged to complete the survey.

The Top Hand award, proposed previously by Mary to recognize members who have been outstanding volunteers, especially those who work on trails, was discussed in detail. Nominations will be sent to Nominating Committee Chair Laura Duncan, and the Nominating committee will decide on the annual winner. The winner's name will be added to an engraved plaque to be presented during the November membership meeting.

Helen asked if there were any announcements or questions. Don asked about donating picnic tables for Empire Mine. He agreed to research the costs involved.

Mary Johnson reported that she and several other members met with Jace Reed and Wayne McCarter at Little Lazier to review what work would be addressed during the GCTC workday there scheduled for the weekend of 6/28/13 through 6/30/13. She noted that a number of projects need attention including: limbing of trees in the area where rigs are parked, raking fire rings, scraping and painting picnic tables, removing bumps and washouts in the access road, and removing at least 6 trees from the PCT connector trail. Mary will send photos of the trees to Willie, as well as a huge tree, which has fallen across the PCT. A water bar may also be needed on the PCT connector trail.

There being no further business, the meeting was adjourned at 8:15.
