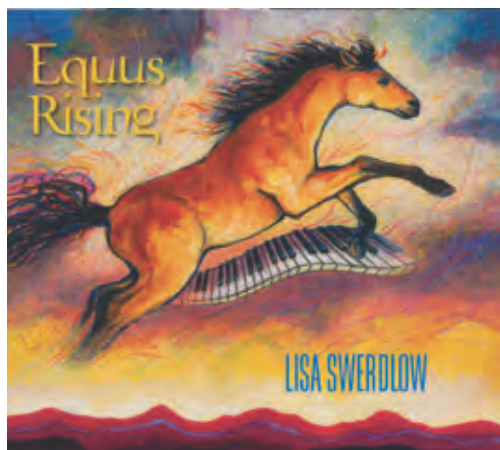
### My Herstory with Horses

At the age of three my father took me to a small amusement park in Los Angeles called Kiddieland. They had ponies that walked, trotted and cantored in circles for 10 cents a ride. I was immediately "in LOVE" with these fabulous four-leggeds. Growing up in L.A. with working-class parents, riding horses was an obsession I could only occasionally satisfy but I did everything I could - from mucking stalls to leading trail rides to exercising other people's horses - just so I could be around my wonderful friends.

I was fifty years young before I could afford to buy my first horse, Sullivan's Travels, a beautiful buckskin Appendix Quarter Horse. Two years later, while living in the Oakland Hills where I boarded Sulli, my wife and I bought our ranch in Chicago Park. Since then we have had up to six horses, including two Paint foals that we bred from our two mares. For the last twelve years, my wonderful horses have blessed my life in innumerable ways.

When I was stricken with a terrible cancer diagnosis four years ago, I could barely walk but I would go and sit in the loafing area and my horses would gather around me, inviting me to share their unconditional love and healing energy. They have a way of knowing when they are needed to heal whatever is causing an imbalance in my life. At first, I wasn't sure if I would ever be able to ride again but within two months of radiation treatment I was back in the saddle and thrilled!

From my bond with my horses and their tremendous compassion and patience with us two-leggeds, I returned to my other great love, the Piano, and composed music that I have recorded on my new debut CD aptly named "Equus Rising". I dedicate this compilation of music to Sullivan's Travels who changed my life in more ways than I can say but all for the better.



I will be performing these original compositions live in concert at St. Joseph's Cultural Center on Saturday, September 23<sup>rd</sup> at 8:00 PM. My CD is available now on Amazon and iTunes and will also be available for sale at the concert. I am honored to be sharing the stage that night with the award-winning group "Gypsy Soul" on their 20<sup>th</sup> Anniversary Tour! Tickets are available at Briar Patch Co-op, online at GypsySoul.com and on my website LisaSwerdlowPiano.com.

I know horses have contributed greatly to all of our lives and continue to each and every day. There is no bond that is more intimate and more dynamic than the one we share with our beautiful "beasts"!

### Silver Lake Adventure

In early August Carol and I spent a few days riding at Silver Lake. We stayed at Plasse’s Resort located about 100 miles from Grass valley and situated at the south end of the lake. If you want to avoid most Tahoe traffic take the Mormon Emigrant Trail off Highway 50 and then go north on Highway 88 for five miles to enter the resort. Be advised that signs for the horse camp area are somewhat suboptimal so drive slowly and don’t hesitate to ask folks for directions (are you listening all you alpha males?)

The campsites were full but we were able to camp in the meadow adjacent to the reserved sites. It’s quite large and, most importantly, fairly flat, making set up relatively easy. There are 22 equestrian sites that can be reserved, as well as many other amenities: general store, restaurant, dumping station, propane station etc. Check the resort’s web page for details (<http://www.plassesresort.com/>). We were able to piggy back off equestrians in the reserved sites to use their water spigots. We brought a splitter and 50 ft of collapsible hose (works great, light weight and easy to store). There are very few trees to highline and we saw all other types of horse confinement: trailer ties, ground ties, hobbling and portable corrals.

Weather was very cooperative being about 70-80 Fahrenheit during the day and 40-50 at night , not surprising because the camp sits at about 7300 feet elevation.

A big caveat is that trails are very poorly marked, if at all. We were very fortunate in that a fellow camper shared with us a map of the area with superimposed “trails” made with a GPS. We input the coordinates into our own units to (roughly) follow the trails. Going north from the camp site you can ride the east shore of Silver Lake and go on to Granite Lake (aply named because most of the “trail” is over granite, elevation about 7600 ft.). Shoes or boots are strongly recommended. Most of the ride is relatively accessible if your horse is fit and watches where they put their feet. At Granite Lake there are natural outcroppings of platforms into the lake giving easy access to horses for water. We tried to “make” a trail from Granite Lake to Thunder Mountain (elevation about 9400 ft., provides a view of Silver Lake on the west and Kirkwood Ski Resort to the east) but had to put it off for another day with more daylight.

If you’d prefer more forest and meadows than mountains, ride south from the camp. Here you can also stop at Hidden Lake or Mud Lake (again, aptly named). These alpine meadows are absolutely stunning and well worth the ride. Going up Connie’s Slide we were able to get to the ridge near Highway 88 (elevation about 8200 ft.) that provides a great overlook of Silver Lake. Be warned this is a popular spot for off road ATVs and mountain bikers but everyone we met was extremely considerate. They’d stop when they saw us and, if signaled to advance, did so in a very slow (and relatively quiet) manner. Also along this ridge there is a natural rock formation with an opening (Porthole Gap) that provides an interesting framing of the lake.



All the fellow equestrians we met were friendly and helpful adding to a very enjoyable experience. We plan to return to take another crack at reaching Thunder Mountain and checking out some of the other nearby areas like Blue Lake and Red Lake. Stay tuned.

### Little Lasier Meadow

The rainy/snowy winter delayed GCTC annual work outing to Little Lasier Meadow from the end of June until the end of July. Although disappointing, it was worth the wait! Blue skies, green meadows, flowers of all colors, and water in the rivers and creeks greeted GCTC members at LLM. The weather was fabulous! Even the rain shower on Sunday... no dust on the drive out!

As in most of the GCTC events, a degree of planning is involved, and the LLM work outing is no exception. Contact is made early in the year with Tahoe National Forest's Mary Westmorland to arrange for the date, so that the campground can be reserved for GCTC. This year, as the original work date in June approached, calls were made to check on access to the camp, which was hampered by late snow. It was decided to move the workday to an available date in July.



The reconnaissance trip to Little Lasier Meadow was made June 30, by Mary and Gail. The TNF workers had recently been able to get to the camp and clear all of the trees that had bent or fallen during the winter, the camp host, Sue (new this year) had moved in, and Pass Creek Loop Road had been graded and cleared of brush along the sides. The day was bright and beautiful; the area was over the top scenic, enhanced by the full rivers and streams. TNF's Mary Westmoreland and Quinten Youngblood met us at the camp to view the clean up by their crew, welcome the camp host, and discuss the projects that GCTC would work on. After the meeting, Mary J., Gail and Sue made some temporary repairs to the corrals for incoming campers. Notes and work project materials were listed for the work weekend.

The next steps involved gathering needed supplies, loading them on a trailer and transporting them to Little Lasier Meadow prior to the work weekend. Mary, with the help of Tom Fletcher met Thursday afternoon, hitched up the trailer (use courtesy of GCTC member Katie Guilliat) and picked up the supplies along with 20 portable corral panels. The next day, Mary, accompanied by Barry and Suzanne Vaccaro, transported and unloaded the supplies and set up the portable corrals at LLM, which could be left there under the watchful eye of the camp host.



The next week GCTC members began arriving at LLM to enjoy some time before the weekend... riding and "relaxing!" True to form, dedicated GCTC members began clearing trails so that riders who came later could negotiate the trails with out hindrance. It is very rewarding to be able to ride and enjoy the trail that you previously cleared!

It was great to welcome the GCTC members as they arrived, direct them to their campsites, help pump water for their thirsty horses and let everyone take a deep breath and "drink in" the beauty of the area. **Cowboy Dressage Clinic**  
**Hosted by Hidden Gait Ranch**

On July 15 and 16 the local Northern California Walking Horse Association sponsored a two day Cowboy Dressage Clinic at the beautiful Hidden Gait Ranch in Grass Valley, California. Cowboy Dressage is a rapidly growing show discipline that focuses on the relationship between horse and rider with an emphasis on the principle of soft feel. The first day focused on the basics of straightness, transitions, bends and stops, which are all elements of riding the tests and good horsemanship. The second day focused on improving the elements and then putting principles to purpose in riding a test. The clinic was taught by one of the founding members of the group, Lyn Ringrose-Moe, and was attended by 12 riders. The majority of the horses were gaited breeds, but in keeping with the inclusive philosophy of the discipline, non-gaited horse and rider teams were encouraged to, and did participate. Fun was had by all.
